December 23rd, 2013

Police received a 911 call to a motor vehicle accident at the corner of 1st Street and Thornhill Street in Morden. Police attended and both drivers of the vehicles were being attended to by paramedics. The driver of one of the vehicles was travelling eastbound on Thornhill Street in the curb lane approaching the intersection of 1st Street. A second vehicle, also travelling east in the median lane, wanted to turn south onto Route 100 and cut across in front of the other vehicle. The two vehicles collided but there were no serious injuries.

December 24th, 2013

Police were on general patrol when they observed a vehicle in the Morden Park around 2:20am. The vehicle exited the park at which time police activated emergency equipment. The vehicle stopped and police approached to speak with the driver and passenger inside. While speaking with the occupants, police noted an odor of marijuana coming from within the vehicle. Police questioned the occupants regarding having any illegal substances at which time the driver handed over a small plastic container from a compartment that contained a green leafy substance. A further search of the vehicle found a small Ziploc baggie containing a green leafy substance believed to be marijuana and some drug paraphernalia inside the vehicle's glove compartment. Also found in the vehicle was a partial bottle of liquor. The 19 year

old driver and 15 year old passenger were issued warnings for Possession of a Controlled Substance and the driver was issued a Provincial Offence Notice for having liquor in a vehicle.

December 27th, 2013

Police received a request from the RCMP for assistance with a well being check of an individual believed to be in Morden. A description of the vehicle was given and police found it parked on Thornhill Street across from the Kopper Kettle Restaurant. Police approached the vehicle and spoke with the female driver. The driver starred ahead and would not answer any of the questions asked. Police tried to ascertain if there was a medical condition but noted a strong odor of liquor on her breath as well as displaying other signs of impairment. When asked to exit the vehicle, the driver required assistance in getting out and was very unsteady on her feet. She was arrested for impaired driving and transported to the police station for breath tests. Several requests were made for the driver to provide sufficient samples of her breath, but she refused to comply. The 57 year old female was charged with fail to provide a breath sample and have care & control of a motor vehicle while impaired. She was released to the care of her husband on a Promise to Appear in Morden Provincial Court in January.

December 27th, 2013

Police were called to a domestic dispute with yelling and screaming regarding a custody concern over the children. The mother was on the driveway of the residence to pick up her children and was not leaving. Police attended and spoke with the woman along with a relative who was there to try and mediate the situation. It was learned that the father and daughter had an altercation and the daughter ended up with a mark on her cheek. Police are continuing their investigation. Police remained on scene to keep the peace and to ensure the situation was settled.

December 29th, 2013

Police were called to a domestic dispute where a girlfriend and mother were at a residence trying to remove a child from the home. Police attended and found the caller to be intoxicated and unsteady on his feet. The mother was trying to leave the residence with their son as the husband had friends over and was drinking. Police mediated the situation and advised the safer place for the child was with the mother for the night. Police remained on scene until the mother and child departed the residence. There were no charges as a result of this incident.

December 16th, 2013

Police received a report of a sexual assault on a 15 year old youth that occurred on November 29th, 2013 at a residence in Morden. The youth was visiting at a residence with a group of people and was introduced to the accused during the course of the evening. The accused had been drinking and admitted to using cocaine that evening and cannot remember a lot of what happened. The youth admitted that she consented to being with the accused however the age of consent is greater than 5 years and an offence under the Criminal Code of Canada. The 22 year old male is charged with 1 count of Sexual Interference and 1 count of Sexual Assault. He will be appearing in Morden Provincial Court in January.

December 16th, 2013

Police received a call of a vehicle that slid into the ditch while leaving Boston Pizza in Morden. Police attended to find a vehicle across from the Boston Pizza in the ditch with one female occupant in the driver's seat. Police spoke with the driver who had no injuries and there was no sign of alcohol being involved. The street was very icy at the time and the driver was not able to stop. The vehicle was towed from the ditch with no further action required.

December 16th, 2013

Police have charged a 44 year old Morden resident with 2 counts of Domestic Assault following an incident. The accused and his wife got into an argument and as a result, the victim was assaulted when grabbed by the arms and then in a separate incident, was hit on the head by a garage door. The 44 year old will be appearing in Morden Provincial Court in January.

December 21st, 2013

Police received a call from Tim Hortons in Morden advising of a male passed out at one of the tables. Police attended and observed and woke the male who was displaying signs of intoxication. The 25 year old male was arrested under the Intoxicated Persons Detention Act and lodged in cells overnight. He was released in the morning when sober without any charges.

December 21st, 2013

Police received another call a few hours later to Tim Hortons in Morden advising of a female asleep at one of the tables. Police attended and attempted to wake the individual without success. An odor of alcohol

could be detected and police eventually arrested the woman under the Intoxicated Persons Detention Act. She was transported to Boundary Trails Regional Health Centre to be cleared for a previous medical issue.

December 21st, 2013

Police were called to a disturbance at a residence in Morden. The accused attended to a residence to speak with her husband who was currently on an order to have no contact with her. The homeowner attempted to stop the woman from entering the home but the woman pushed past and confronted the victim. She was demanding money and when refused, she began pushing and hitting him with her purse. The 28 year old female was arrested for domestic assault and released on a Promise to Appear in Morden Provincial Court in January.

December 22nd, 2013

Police received a call from a business in Morden advising that an individual was in the store and being argumentative with some of the employees. They also suspected that the individual was intoxicated and now in a vehicle outside the store. Police attended and observed the vehicle leaving the location. Police followed the vehicle and in a short time, observed the vehicle to be wondering on the roadway and nearly missed hitting a parked vehicle. Police activated emergency lights and the vehicle came to a stop in the middle of the road for a short duration then continued driving. The vehicle then turned into a parking lot and stopped. The driver exited the vehicle and appeared to be unsteady on his feet. Police spoke with the driver who showed signs of impairment including an odor of liquor on his breath. The driver was arrested for impaired driving and transported to the Morden Police Service for tests. Breath tests resulted in readings of 190mg%. The 64 year old Morden resident was charged with Impaired Driving and Driving over .08. The vehicle was impounded and the driver issued a suspension notice along with a Promise to Appear in Morden Provincial Court in January.

December 2nd, 2013

On December 2nd, Morden Police Service reported that they were investigating a break, enter and theft from several storage units at Blue Rock Storage in Morden. Police had recovered several items such as tents, a socket tool set, a reciprocating saw, a Makita drill, a generator and some tires related to this incident. Police had charged a 19 year old Winkler resident with 8 counts of break and enter with intent, 4 counts of break, enter and theft, 2 counts of breach of undertaking and 1 count of breach of Probation. Two other individuals, 20 and 22 years of age, have now been arrested and charged in relation to this incident. Several more stolen items were recovered by police including a chain saw, Skill saw, Reciprocating saw, grinder and an assortment of other tools. Total value of all items stolen is well over \$5000.00. Both individuals have been charged with 4 counts as well as 8 counts of break and enter with intent. All three individuals will be appearing in Morden Provincial Court in January 2014.

December 9th, 2013

Police were called to a motor vehicle accident on North Railway Street at the intersection of Nelson Street in Morden.

A vehicle was exiting a parking lot and slid on ice into the street, colliding with another vehicle that was travelling west bound on North Railway Street. There were no injuries as a result of the accident but one of the vehicles required towing.

December 10th, 2013

Police received a complaint of a hit and run motor vehicle accident that occurred on December 6th sometime between 6:30pm -8:30pm while parked in the parking lot of Rock's Bar & Grill. The driver returned to his vehicle, 2009 black Pontiac G8, to find damage to right rear fender. Anyone with information regarding this incident is asked to call the Morden Police Service at 822-4900 or Crimestoppers at 1-800-222-8477.

December 10th, 2013

Police have charged a 29 year old male with 1 count of assault and 2 counts of failing to comply with a probation order following a domestic dispute. Police were called to a residence in Morden where a woman was assaulted by her boyfriend following an argument. The woman was hit in the face once and twice on the back. The accused was currently on a probation order out of Ontario with conditions to keep the peace

as well as not to associate or contact the victim. There was also a Warrant for the accused's arrest in Ontario for theft and breach of probation. The accused was remanded into custody and transported to the Winnipeg Remand Centre where he awaits his next court appearance.

December 10th, 2013

Police were called to a residence in Morden regarding a theft of a motor vehicle by an ex-boyfriend. Police learned that the vehicle taken was actually in both the victim's and accused's names. The accused was however on an order to have no contact or communication with the victim. As well, the victim was on an undertaking to have no contact or communication with the accused. It was learned that both had been texting each other. As a result, the 21 year old male was charged with 1 count of breach of a court order and the 33 year old female charged with 1 count of breach of undertaking. Both will be appearing in Morden Provincial Court in January.

December 11th, 2013

Morden Police Service K9 unit was called to assist the Winkler Police Service with a break and enter to the Superstore in Winkler. The suspect was believed to still be inside the store. PSD Chase was deployed and a search of the interior of the store determined that the suspect had already exited the building. Winkler Police Service is continuing to investigate.

December 12th, 2013

Police have a Warrant for Arrest for Alex Devon Lane Klassen of Winnipeg for failing to attend court. Klassen was originally charged with several offences including assault, causing a disturbance, fail to comply with an undertaking and fail to comply with a promise to appear. The accused was to attend court on December 10th, 2013 but failed to do so. Anyone with information regarding Klassen's whereabouts is asked to call the Morden Police Service at 822-4900 or Crimestoppers at 1-800-222-8477.

December 13th, 2013

Police received a report of a vehicle that was broken into while parked in the parking lot of the Access Event Centre in Morden between 12:45pm and 3:30pm this date. The owner returned to the vehicle to find that the keyhole on the driver's side door was pushed in and some money taken from inside. The vehicle that was entered was a 2004 grey Chevrolet Optra. Anyone with information regarding this incident is asked to call the Morden Police Service at 822-4900 or Crimestoppers at 1-800-222-8477.

December 13th, 2013

Police received a call to Rock's Bar & Grill regarding multiple people fighting inside the bar. Police attended to find a large crowd outside with two males exchanging words and yelling at each other. Police tried to talk to one of the individuals in an effort to calm the situation but the individual was agitated and aggressive towards police. The individual refused to respond to officer's commands and was restrained and arrested for being disorderly in a licensed premise. The individual was lodged in cells overnight under

the Intoxicated Persons Detention Act and released in the morning when sober. The 18 year old Morden resident was charged with Being Disorderly in a Licensed Premise under the Liquor Control Act.

December 15th, 2013

Police have charged a 19 year old Morden resident with 3 counts of Breach of Recognizance for having contact/communication with a victim. The accused was placed on Recognizance to have no contact with his girlfriend following a previous domestic assault. Police observed a vehicle travelling down a street in Morden with both the accused and the victim inside. The vehicle was stopped and the accused was arrested and charged with 1 count of breach of Recognizance for being in contact with the victim as well as 1 count of breach of Recognizance for being in possession of a controlled substance. He was released on a Promise to Appear in January. Just a few hours later, police observed the accused's vehicle parked in front of the victim's residence. Police attended to the residence to conduct a wellbeing check on the victim. Police found the accused in the residence and he was arrested once again for breach of Recognizance. This time he was remanded into custody and transported to Portage Provincial Court. The accused immediately disposed of these charges as well as previous charges he was facing and was released on 18 months probation on all charges.

December 2nd, 2013

Police received a call from an individual advising that his storage unit that he rents from Blue Rock Storage in Morden was broken in to. Police attended and were advised that the lock on his storage unit was cut to gain entry and several items were removed from inside. While investigating, police observed that 11 other units had been broken as well by cutting off the locks. Through investigation, police learned that an individual was trying to sell items such as a generator and chain saw, which was a couple of the items that were taken from the storage units. Police attended to the suspects residence where some items were located that could be tied to the break and enters at the storage units. Several other items such as tents, a socket tool set, a reciprocating saw, and a Makita drill were turned over to police by the suspect. Police were also able to locate a generator and tires inside

a culvert where suspects hid items after committing the break, enter and theft. As a result of the investigation, police have charged a 19 year old Winkler resident with 8 counts of break and enter with intent, 4 counts of break, enter and theft, 2 counts of breach of undertaking and 1 count of breach of Probation. The accused was remanded and remains in custody at the Winnipeg Remand Centre awaiting his next court appearance. Police are continuing their investigation with more arrests and charges to follow.

December 2nd, 2013

Police had reason to stop a vehicle believed to be involved in drug activity. As a result of the stop, a quantity of marihuana was seized along with drug paraphernalia. A 26 year old Plum Coulee resident was issued a warning for possession of a Controlled Substance.

December 5th, 2013

Police received a complaint of a hit and run that occurred this date sometime between 9:30am and 11:00am in while parked in front of the Morden Library. The driver returned to his vehicle, a grey 2005 Buick Allure, to find extensive damage to the front bumper. Anyone with information regarding this incident is asked to call the Morden Police Service at 822-4900 or Crimestoppers at 1-800-222-8477.

December 5th, 2013

Police are investigating the sexual assault of a 15 year old female. The victim met the suspect at a party where the assault took place. Police are continuing their investigation.

December 6th, 2013

Police were on general patrol when they observed a vehicle being driven by an individual known to drive without a valid driver's license. The suspect vehicle was stopped after being observed weaving in its lane. Police spoke with the driver who showed signs of impairment including an odor of liquor. There was an open can of beer noted on the floor of the vehicle by the passenger's feet. The driver was asked to exit the vehicle and was unsteady on his feet. The driver was arrested for impaired driving. Tests were administered resulting in readings of 120mg%. The 38 year old driver was charged with impaired driving, driving over .08, have liquor in an unauthorized place, drive with an invalid license and misuse of plates. The accused will be appearing in Morden Provincial Court in January 2014.

Robbery

Morden Police Service have arrested and charged a 22 year old Morden resident with Robbery, Possession of a Weapon for a Dangerous Purpose and Disguise with Intent following an incident the evening of December 3rd. Morden Police Service received a call around 9:30pm Tuesday evening from an employee at a local business advising a male just attended the store and attempted a robbery. The suspect produced a knife and had a bandana over their face, demanding the employee hand over all the money in the store. The employee refused to hand over the money at which time the suspect fled on foot. PSD Chase was deployed and tracked the suspect from the business to an apartment door. Police spoke with the occupants of the apartment and determined that one of the persons present was responsible. The suspect was arrested and transported to Morden Police Service. A warrant was obtained to search the apartment where items were seized related to the robbery.

22 year old **Kevin Sean Thiessen** has been remanded into custody awaiting his next court appearance.

December 4th, 2013

The Morden Police Service and the Oxford House Royal Canadian Mounted Police Detachment are pleased to participate once again in the "Koats for Kids program", with generous donations from the Morden and District United Way. This is the 3rd year that Morden Police and the RCMP have teamed up to take part in this worthwhile venture.

Sgt. Sean Aune of the Morden Police Service contacted Cpl. Rod Campbell this year, now stationed in Headingley, to see if there was interest once again to participate in the program. November 25th, 2013

On October 13th, police received a report of a theft of motor vehicle that occurred around noon that date. The driver parked his 2004 blue BMW on Stephen Street just east of the Agassiz Credit Union. He returned a short time later to find his vehicle gone. Later this day, the driver spotted his vehicle which was now parked on Gilmour Street at the intersection of 9th Street with damage to the front passenger's side bumper and tire. Through investigation along with the public's assistance, police have concluded their investigation into this incident. Police have charged a youth for Public Mischief and Make a False Statement under the Highway Traffic Act after the investigation proved that his damaged car reported as stolen, was in fact not. The accused youth had caused damage to the vehicle and rather than taking responsibility, made a false police report and reported it had been stolen. The youth is scheduled to appear in Morden Provincial court in December.

November 26th, 2013

Police observed a vehicle approach a stop sign at a high rate of speed. The vehicle came to a stop then proceeded again at a high rate of speed. Police eventually stopped the vehicle and spoke with the driver who had an odor of liquor on his breath. A demand was made for the driver to provide a sample of his breath on the roadside screening device. The test resulted in a warning indication and as a result, the driver was issued a 24 hour suspension of his driver's license.

November 26th, 2013

Police are investigating yet another residential break, enter and theft. A residence on Willow Creek Place in Morden was entered sometime this date between 10:00am and 5:00pm. Suspects entered the home and removed several items of jewellery. Police are asking anyone with information regarding this incident to call the Morden Police Service at 822-4900 or Crimestoppers at 1-800-222-8477.

November 26th, 2013

Police received a report of a vehicle that was entered and rummaged through. The vehicle was unlocked at the time and suspects went through the center console and glove box. Police are reminding the public to lock their vehicles and remove valuables from inside. Anyone with information regarding this incident is asked to call the Morden Police Service at 822-4900 or Crimestoppers at 1-800-222-8477.

November 27th, 2013

Police have charged a 16 year old youth with failing to comply with a probation order. The youth was on probation as a result of a break, enter & theft to a residence, weapons charges, and several counts of failing to comply with conditions of his undertaking. The youth again failed to comply with the conditions of his probation and will be appearing in Morden Provincial Court in December.

November 30th, 2013

Police received a report of a hit and run motor vehicle accident that occurred this date in the 200 block of 8th Street in Morden. The driver was parked on the street and came out to her vehicle to find damage to the quarter panel in front of the driver's door. The vehicle that was damaged is a 2007 grey Pontiac Torrent. Anyone with information regarding this incident is asked to call the Morden Police Service at 822-4900 or Crimestoppers at 1-800-222-8477.

December 1st, 2013

Police had opportunity to speak with a 4 individuals at the Star Motel in Morden. All individuals had consumed liquor with three being youth. The three youth, ages 15-17, were charged under the Liquor Control Act with consuming liquor under 18 years of age. The adult male, age 21, was charged with supplying liquor to a person under 18 years of age.

December 1st, 2013

Police received a call from Huron Windows located at 345 Mountain Street South in Morden regarding snowmobiles trespassing across their lawn and causing damage. There is "no trespassing" signs located on the property but are being ignored by snowmobilers. Morden Police would like to remind the public of the Snowmobile By-laws and to respect private property. November 18th, 2013

Police have arrested and charged a 19 year old Winkler resident with 2 counts of Breach of Undertaking. The 19 year old failed to attend court on November 12th on charges of Assault and Mischief. Police arrested the accused and determined that he had consumed liquor, which was in breach of his conditions. The accused was remanded into custody and will be appearing in Portage Provincial court on November 25th.

November 19th, 2013

Police received information of a group of students that were planning to attend a location by the Access Event Centre to smoke marihuana. Police attended and found a group of 5 individuals; 4 youth ages 15 and 16 as well as one adult male. The individuals were questioned at which time one of them handed over a small plastic baggie with a small quantity of marihuana. Checks on these individuals revealed that there were court orders prohibiting several of these individuals from having contact or communication with each other. As a result, 3 of the youth as well as the 1 male adult were charged with breach of Probation and Breach of Undertaking. All four individuals will be appearing in Morden Provincial Court in December.

November 19th, 2013

Police were called to a possible domestic assault at a residence in Morden. A witness observed a mother and daughter arguing and yelling outside their residence and at one point, thought the daughter was assaulted. Police attended and spoke with both individuals separately to get their account of what occurred. Both indicated that an argument did take place with a lot of yelling and arguing but at no time was anyone assaulted. Police remained on scene to mediate the situation and ensure that no other offence took place. There were no charges as a result of this incident.

November 20th, 2013

Police are investigating a motor vehicle accident that took out the pedestrian corridor light standard at the corner of Thornhill Street and 5th Street in Morden. A vehicle was travelling west bound, at what appeared to be a high rate of speed, and attempted to turn south onto 5th Street but lost control. The vehicle hit the pedestrian corridor light standard knocking it over. Manitoba Infrastructure and Transportation crews were called from Winnipeg to replace and repair the light. The vehicle involved in the accident was a blue 1999 Chevrolet Astro van with a Alberta license plate. Anyone with information regarding this accident is asked to call the Morden Police Service at 822-4900.

November 21st, 2013

Police received a call from a resident advising that they received a call from a person claiming to be from “Windows Tech Support”. The caller asked the person to make some changes on their computer but the caller refused. The caller thought this to be a scam and wanted to pass the information on to police. The public is reminded to use caution when calls such as this are received and to ensure they are aware of the authenticity of the call before giving out any personal information or acting on such requests.

A 15 year old male youth has been charged with Breaching his probation when he failed to comply with conditions to attend and participate in a program as directed by the courts. The youth will be appearing in Morden Provincial Court in December.

November 21st, 2013

Police have remanded a 34 year old female into custody for breaching her court order. The female was to have no contact or communication with a certain business in Morden but continues to call the business and harass the staff. The accused remains in custody awaiting her next court appearance.

MEDIA RELEASE

November 21st, 2013

The Morden Police Service has concluded its Distracted Driver Enforcement Program. The program was funded by Manitoba Public Insurance and works in conjunction with Police Services to enhance enforcement through organized enforcement activity in order to detect infractions – particularly related to distracted driving offences. Four separate dates were designated where Morden police participated in the MPI funded program that allowed officers to come in on their own time for extra enforcement. The purpose of the program was to increase public awareness of the risks and consequences of distracted driving and to deter the use of hand-operated electronic devices while driving. Over the four day campaign, officers issued a total of 36 offence notices, 22 of which were for using a cellular telephone or other hand-operated electronic device while driving. Although the program has concluded, Morden Police Service will continue to enforce distracted driving law. **The fine for using a cellular telephone or other hand-operated electronic device while driving is \$203.80 plus demerit points.**

You may have noticed an increased presence of police patrols around the schools in Morden over the past couple of weeks. This is due in part to an MPI funded School Safety Enforcement Program that the Morden Police Service has been involved with. The extra patrols began on October 15th and ran through until October 25th with shifts running from 8:30am – 1:00pm and 12:00pm – 4:00pm. Patrols were stationary, monitoring traffic in various locations, as well as roving patrols around all the schools in Morden. The purpose of this program was to enhance the presence of officers already in and around the school zones to detect infractions – particularly infractions related to school buses and school zones (such as passing stopped school buses, failing to yield right of way to pedestrians at marked corridors, passing vehicles stopped for pedestrians, distracted driving offences, failure to wear a seatbelt and speeding). During this time period, Morden Police Service issued a total of 32 offences notices for infractions including speeding, fail to wear seatbelt, disobey traffic control device – stop signs and red lights, pass school bus and use a cellular device. The hope is to be able to run these programs several times

throughout the school year in conjunction with our regular patrols to help maintain a safe environment in and around the school zones.

was then realized that the suspect had already attempted to obtain funds from the victim's account. No money was actually transferred or lost from the victim's account. Police are reminding the public not to give out any personal information to anyone unless absolutely sure of the person's identity. home and noted an odor of marihuana coming from the youth. At first the youth denied having any illegal substances, but eventually turned over a small amount of marihuana. The youth was turned over to an adult and explained the offence notice for failing to wear a helmet as well as being in possession of a controlled substance. The youth will be referred to Alternative Measures regarding possession of a controlled substance.

Police have arrested and charged an 18 year old male from Morden with Fail to Attend Court, Possession of a Controlled Substance to wit: Cannabis, 2 counts of Fail to Comply with Undertaking to wit: Keep the Peace and be of Good Behaviour, as well as Fail to Comply with Undertaking to wit: Not to possess any materials, paraphernalia or packaging related to the use of illegal drugs. The accused failed to attend court on June 11th and a Warrant for Arrest was issued. The accused was arrested on June 13th on the strength of the Arrest Warrant. He was found to be in possession of a controlled substance at the time of arrest. He will be appearing in Morden Provincial Court in July.

The 37 year old was found guilty of Theft over \$5000.00 in Morden Provincial Court on April 23rd 2013 and received a one year Conditional Sentence Order requiring he pay back \$18,000.00 to the company.
