6.0 Executive Reports

A: Chief's Reports – The Chief of Police thanked the Police Board for the presentation of the shadow box for his 35 years of service. He thanked them for all the support over the years. The Chief welcomed the new Inspector Sean Aune to the board and advised he would be attending the meetings in the future. The police board was updated on the church incident from Sunday. The Chief advised that the officers used their fast thinking and would like to knowledge these officers for their efforts. With the promotion of Sean Aune to Inspector, the Chief stated that the application process for the Sergeant position has begun and the deadline is March 22. The police service is hopeful that the new sergeant position will be filled by summer. He stated that 2 members are in training for the Acting Sergeant as well. Manitoba Association Chief of Police offered a free management course through the U of M Asper School of Business, and Sgt. Flook attended and successful completed it. Cst. Canart, newest member of the RSTT, will be attending Basic Tactical Operators Course in Winnipeg for 7 weeks. Chief of Police advised that Sgt. Flook attended a meeting with the provincial vaccine reps about the COVID Vaccine Site. He stated that they will be hiring private security and will monitoring the site.

B. Strategic Plan Measurement Update

The Plan is on track for the most part but due to COVID 19, some aspects are on hold. The service managed to fulfill the checks stops and will be having more checks in the spring and fall. COPP is in the works and there will be a public meeting to see if their interest.
